三、修課方式	<p>(一)學生與授課教師聯繫，商討課程銜接及自主學習等問題。</p> <p>(二)由課務組通知系所，學生因防疫無法上課期間，經授課教師同意下，由助教於課程後一週內，上傳課程內容或拍攝的影音檔至學校的數位學習平台，設限供修課同學自行上網觀看。若無法提供，請授課教師指派助教協助補課及課輔事宜。衍生之助教費用由開課系所向教務處專案申請研究生獎助學金支應。</p>
四、考試成績	<p>各系所因學生防疫無法全程參與課程或各項評量者，授課教師得依科目性質，調整成績評定方式，以補考或其他補救措施處理成績，補考成績並按實際成績計算。</p>

九、學校相關輔導協助機制	<p>(一)授課老師因防疫得指派助教協助補課或課輔事宜，衍生之費用由開課系所向教務處專案申請研究生獎助學金支應。</p> <p>(二)學校建立輔導單一窗口，追蹤個案現況及後續修業維護。</p> <p>(三)學校處理學生就學事宜，會依相關規定辦理，並注意個人資料保護事宜。</p>

Course Enrollment	<p>(1) Course Drop/Add period</p> <p>1.1 The Course Add and Drop period starts from Feb. 26<sup>th</sup> to March 16<sup>th</sup>. The Courses are not yet full or without limitation of the student numbers, can be added and dropped directly on the system.</p> <p>1.2 The course is full or not be added through the system can refer to the following application procedure.</p> <p>Step 1- Download the "Form for enrollment in courses with limit" via "Tsing Hua Academic Information System" before the end of Add-or-drop Selection (March 16th).</p> <p>Step 2- Get approval from the instructor via email</p> <p>Step 3- Send the Application form and approved email to the department offering the course.</p> <p>Step 4- The department will get approval from their chair and send the documents to the Division of Curriculum for you.</p> <p>Step 5- log into the "Students' Inquiry System " to check out for the results of the selection.</p> <ul style="list-style-type: none"> <li>● For the courses that require attendance for the 1<sup>st</sup> class :               <ol style="list-style-type: none"> <li>A. For those students who are unable to return school due to coronavirus prevention, the Division of Curriculum has notified the instructors to take them into the consideration list of extra course selection and suggested provide TA's email on the syllabus.</li> <li>B. Students who would like to add courses are required to send an email to the instructor in advance stating the reason for your absence for the courses that require attendance for the 1st class and explain the reasons why you want to choose this course. If you couldn't contact the teacher or TA, you may ask the Division of Curriculum for help.</li> <li>C. If you cannot catch up with the lessons due to your absence during this period, you may hand in a special request to drop the course or select another course upon the instructor's approval via email</li> </ol> </li> </ul>

Registration payment	<p>For the student who cannot return to school due to the Covid-19 prevention, can do the payment for tuition fee. Credit fee, and suspension by these methods :</p> <ul style="list-style-type: none"> <li>a. Please do remark your <b><u>student ID number</u></b> and <b><u>payment ID</u></b> during the payment.</li> <li>2. The processing fee will be applied by using telegraphic transfer. Please check your transfer amount causing by the floating exchange rate. If your transfer amount is more than our required tuition fee, the balance would be refunded to your bank account registered in the University or refunded by cheque. If the student can't return to the school within six weeks after registration day and there are no alternative methods of study, the student should apply for the suspension since the student cannot attend 1/3 of the course. The suspension will not count into the suspension period. There is no need to pay tuition fee, credit fee or any other related payment once student is suspended.</li> </ol>
Course Implementation Methods	<ol style="list-style-type: none"> <li>(1) Students should contact the instructors to discuss issues such as course connection and self-learning.</li> <li>(2) Curriculum Division will notify each department. With the consent of the instructor, the teaching assistant may upload the course content or video files to the school's e-Learning platform within one week after the course. Online courses are limited for students enrolled to watch and study online. Evaluation method is determined by the instructor. If an online course is not available, please ask the instructor to assign a teaching assistant to assist in a make-up class or supplementary study. The department can apply for postgraduate scholarship from office of academic affairs for TA payment</li> </ol>
Result	<p>Students who are unable to attend classes or examination evaluation due to coronavirus prevention, their instructors can make flexible adjustments to measure their achievement according to the nature of each subject, such as make-up examination, etc. The make up examination result will view as the formal examination result.</p>
Leave for absence	<ol style="list-style-type: none"> <li>(1) Students who cannot attend classes due to coronavirus prevention of Home Isolation or Home Quarantine, please apply for leave and contact the instructor yourself, and stating the reason for your absence.</li> <li>(2) Division of Curriculum will notify the instructor, not counting student's leave into the record of absence, not be limited by the rules of final score</li> </ol>

For student who is taking course, can apply for tuition fee refund according to the rules of MOE of Taiwan.</p> <p>(3) Students who failed the course and facing the expel from NTHU because of their mental and physical condition affected by nCov-2019 can provide a Doctor's diagnosis certificate to revoke withdrawal from NTHU.</p>
Graduation	<p>(1) Students who fail to complete their degree program requirements, coursework and credits or graduation requirements due to epidemic prevention can submit application to the department. If an approval is confirmed in a department-level meeting and discussion, alternative courses or practices will be provided to assist students. Graduate students who need to take master/doctoral degree examinations during the semester can be examined through online video interview.</p> <p>(2) Students who cannot personally carry out the graduation and school-leaving procedures within the time limit due to epidemic prevention may entrust others to carry out the procedures.</p>
Reservation of Qualifications and Rights	<p>(1) For Dual Degree Students: If students would like to keep their dual degree program, NTHU will negotiate with their host university and keep their eligibility of dual degree Scholarship.</p> <p>(2) For Exchange Student: NTHU will help student to negotiate with Oversea University Partners for the eligibility of exchange student. Oversea University Partners reserve the right to retain or terminate the eligibility of exchange student.</p>
Counseling Department from NTHU	<p>(1) The Instructor can assign a teaching assistant to assist in a make-up class or supplementary study. The department can apply for Graduate Scholarship from the office of academic affairs for TA payment.</p>

	<p>(2) NTHU will provide a single contact window for Counseling and track the students' mental and physical condition and learning situation.</p> <p>(3) To protect student privacy, NTHU administrates student education in line with relevant regulations and pays attention to the protection of personal confidentiality.</p>
Other, Scholarship	<p>(1) Scholarship retention can be applied on winners of NTHU scholarships (Scholarship for mainland China Student, NTHU President Scholarship, NTHU International Student Scholarship) during study suspension due to coronavirus prevention. Students can continue to receive the scholarship after a schooling resumption.</p> <p>(2) Scholarship administrators can obtain free transcripts of applicants' semester grades from the Registrar Division, if students due to epidemic prevention are unable to return to the school to apply for transcripts of semester grades required by the scholarship application.</p>

Who is eligible for the Flexible Study Program?

1. Students who are prohibited to enter Taiwan due to the prevention of the coronavirus after registration date on March 2<sup>nd</sup>
2. Students who are required to put in quarantine or conduct self-health management after registration date on March 2<sup>nd</sup>
